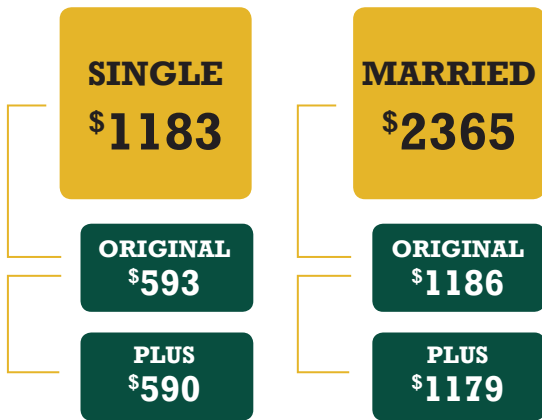

What is the Arizona Individual Tuition Tax Credit?

A tuition tax credit program established in 1997 to allow Arizona taxpayers to redirect their tax dollars to help Arizona's children have a choice in their education.

2020 MAXIMUM ALLOWED CREDITS



Who can give?

Any Arizona taxpayer may give to support this program with a redirection of the tax dollars paid to the state of Arizona.

Why should I give?

This is one of the few opportunities you have to redirect your Arizona tax dollars, and you can help a worthy student.

When can I give?

You can give any time throughout the year; either in several payments or in one lump sum.

What is the PLUS program?

The PLUS tax credit is specifically intended to bridge the gap for children who have had difficulty accessing a tax-credit scholarship. For that reason, existing scholarship recipients are not eligible for a PLUS scholarship. Please see website for eligibility.

IMPORTANT NOTE: This program may only be contributed to by those who have donated the full \$593 (single) or \$1186 (married filing jointly) amount under the Individual Scholarship Program for the tax year in which the PLUS is being claimed.

How do I give?

- 2 Use the Withholding Reduction Program (see website for details)
